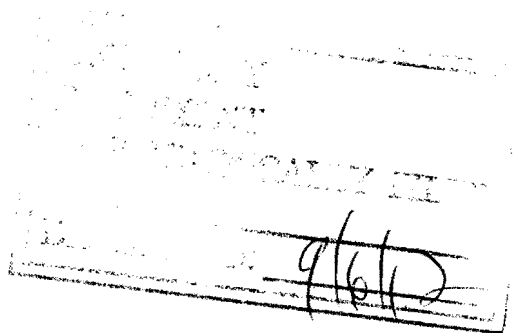

ORDER

Pursuant to the stipulation of the parties and this Court's authority under 9 U.S.C. §§ 201 – 208, the Court grants the Petition of petitioner AXA Versicherung AG, on its own behalf and as successor in interest to Albingia Versicherungs AG, ("AXA") to confirm the Final Award attached as Exhibit A to the Petition, rendered by an arbitration panel on or about July 27, 2012, in an arbitration between petitioner AXA and respondents New Hampshire Insurance Company, American Home Assurance Company, and National Union Fire Insurance Company of Pittsburgh, Pennsylvania.

On August 6, 2012, the Part 1 Judge ordered that the Final Award be filed under seal pending further order of this Court. This Court, having considered the application of respondents to maintain the Final Award under seal, denies the application and hereby orders the clerk to unseal the Final Award attached as Exhibit A to the Petition and orders that petitioner AXA shall

file on the docket a complete copy of the Final Award attached as Exhibit A to the Petition.

WHEREAS, on July 27, 2012, the panel of arbitrators issued a Final Award (the “Final Award”);


