Knoerzer dated April 5, 2016 with annexed Exhibits 1-11 (one through eleven) and Memorandum of Law in support submitted herewith, Plaintiff National Indemnity Company ("NICO") hereby moves, before the Honorable Naomi R. Buchwald, United States District Judge, 500 Pearl Street, Courtroom 21A, New York, New York 10007, as soon as counsel may be heard, for an order, pursuant to 28 U.S.C, §2202 and this Court's equitable power to enforce its own judgments: (1) directing IRB to reimburse NICO for its fees and costs incurred as of March 31, 2016 in National Indemnit Company v.
